Agricultural trade happens every day. Too little of it is coordinated well enough to scale.

What is missing is a shared process to verify, track, and coordinate existing trade.

Why now: agricultural commerce is ready for a coordination layer



1. Digital payment rails already exist

Existing mobile money and digital payment channels can support transaction verification and settlement without requiring new infrastructure.

The rails exist.



2. Commercial activity remains fragmented

While trade happens, logistics, agreements, and records remain disjointed across disconnected calls, messages, and informal records.

The workflow is still fragmented.

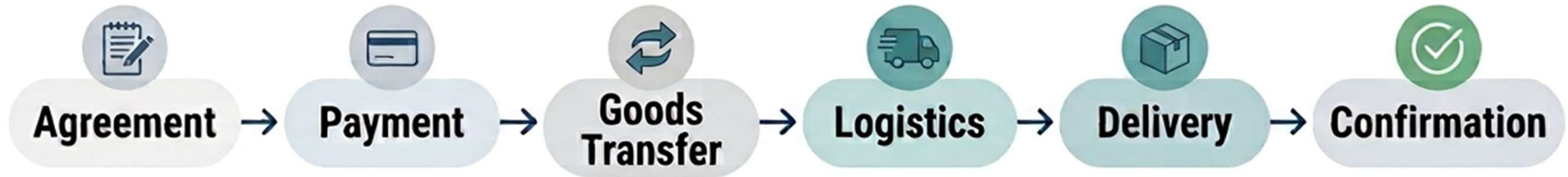


3. Verified transaction data creates strategic value

Every completed transaction can now generate structured information about pricing, demand, fulfillment and reliability.

The rails exist. Trade is active. Grow Mobile adds the coordination layer that turns commercial activity into verified transactions and usable Market Intelligence.

Verification, shared status and commercial records across every stage

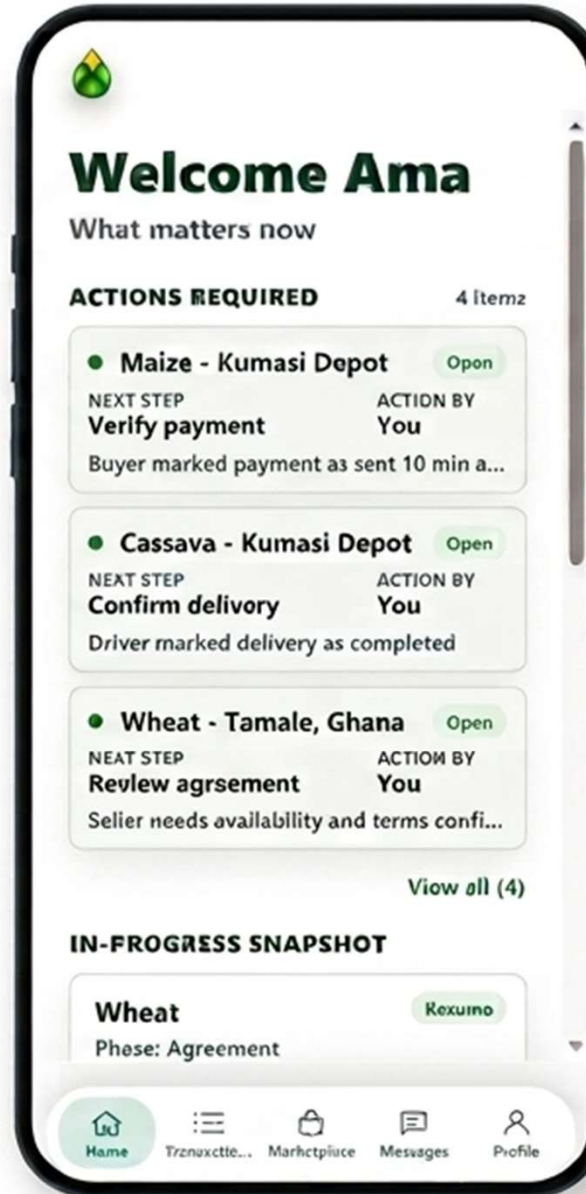
The objective is not mass adoption. It is a functioning commercial ecosystem with repeat, verified transactions.

How it works

Transactions move forward through role-based actions. Grow Mobile shows the next required step, who owns it, and what evidence or confirmation is still needed.

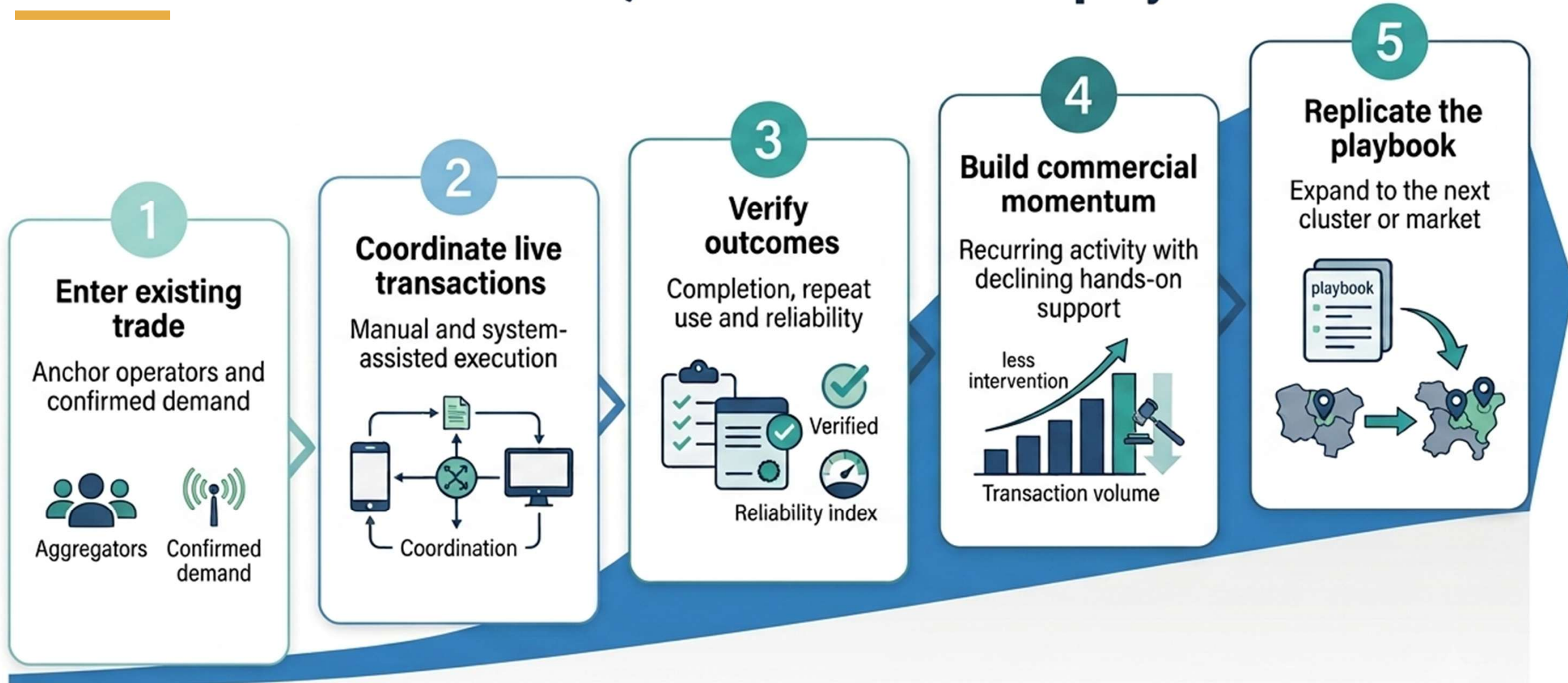
- Highlights actions that require attention
- Shows the current status of each transaction
- Assigns responsibility clearly
- Preserves updates and evidence in one transaction record



What changes

- Participants know what to do next
- Delays and missed handoffs become visible
- Payment, delivery, and confirmation are easier to verify and track
- Evidence stays tied to the transaction
- Completed transactions become permanent commercial records

Go-to-market: cluster-first, transaction-led deployment



Growth comes from successful transactions, not paid user acquisition.

Focused entry. Regional ambition.

Ghana: launch and validation market

- Complete the MVP and activate three commercial ecosystems
- Coordinate and verify live agricultural transactions
- Demonstrate repeat use and improved completion reliability
- Produce the evidence required for an institutional Seed raise

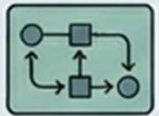
Post-Validation Pathway



Grow Mobile proves the operating model in Ghana, then expands only where local readiness and commercial demand support replication.

What we know today. What the Pre-Seed must prove.

Evidence and capabilities established



- 15+ farmer and market-participant interviews identified recurring coordination failures
- Transaction walkthroughs exposed payment, logistics, delivery and trust breakdowns
- Manual pilot method and role-based operating workflow defined
- Initial Ghana field interview and transaction walkthrough completed
- Smartphone prototype and six-phase transaction flow developed

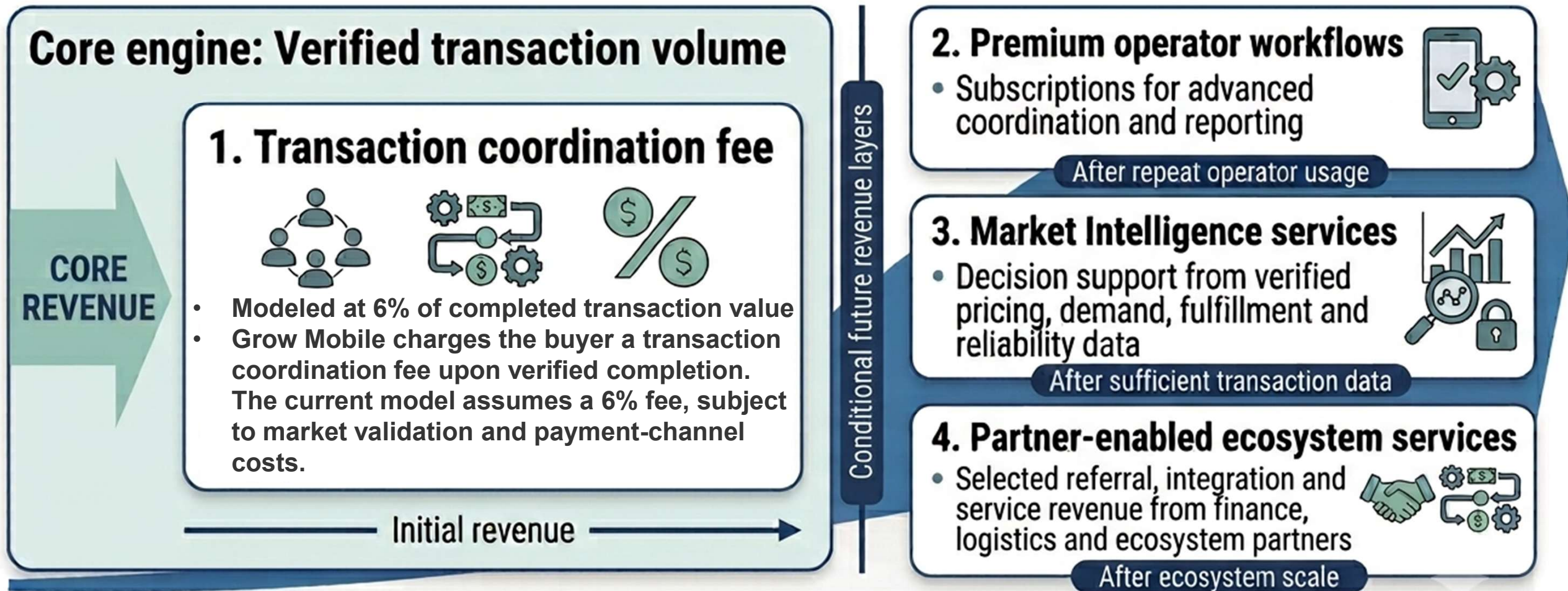
Pre-Seed proof points

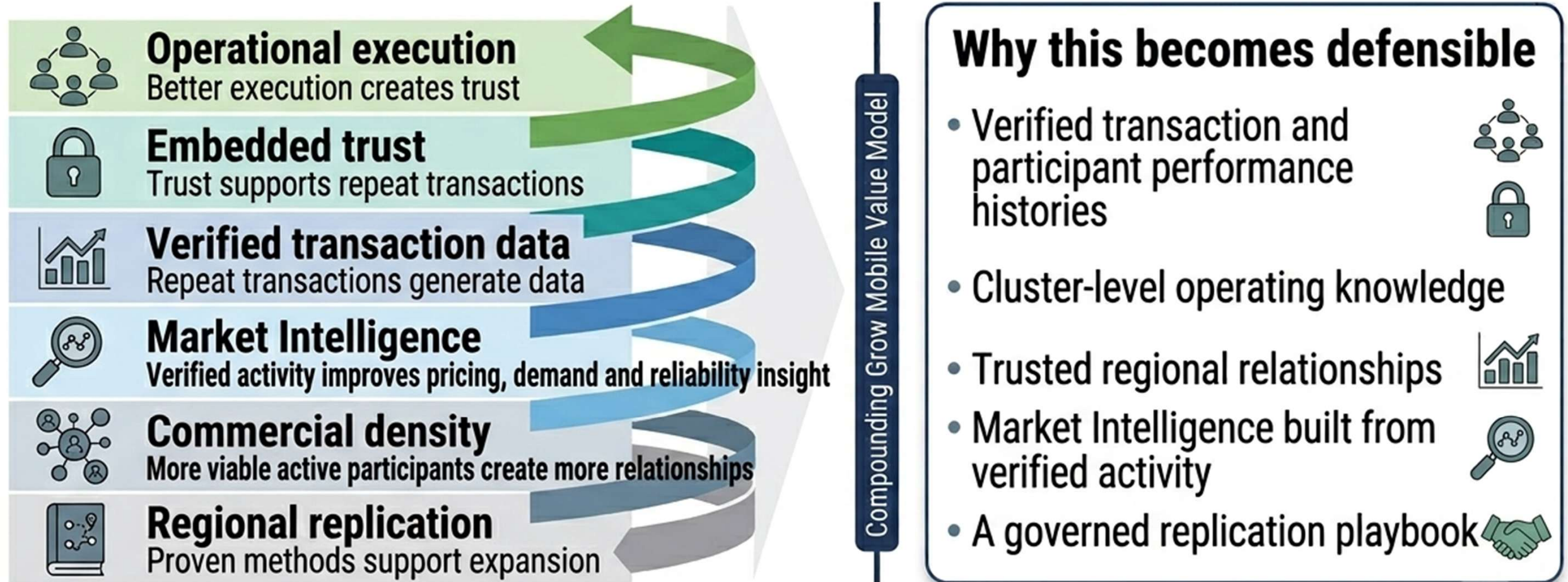
The Pre-Seed converts informed assumptions and early field evidence into repeatable commercial proof.

Business model: transaction revenue first



Transaction revenue supports the initial business model. Additional revenue layers activate only after usage, data and ecosystem maturity justify them.

Every verified transaction strengthens the system



Features can be copied. Execution advantages compound through verified activity, trusted relationships and accumulated Market Intelligence.

Grow Mobile's repeatable operating unit

A cluster

A cluster is Grow Mobile's repeatable operating unit: a geographically concentrated commercial ecosystem of buyers, aggregators, transport providers, farmers, and producer groups supporting recurring agricultural transactions.



Modeled Year 5 pathway

Grow Mobile scales by building dense, repeatable commercial ecosystems rather than pursuing universal market penetration. Each validated cluster becomes a repeatable unit for regional expansion.

Modeled average active cluster in Year 5

22 commercial anchors | ~2,214 annual transactions | ~\$1,451 average transaction | ~\$3.21M annual GMV | ~\$193K modeled platform revenue

Financial pathway: controlled investment to scale

The model reflects three years of controlled investment followed by operating leverage as transaction density increases across clusters.

Model assumes \$1.0M Pre-Seed funding at launch and \$5.0M Institutional Seed funding following successful validation. No Series A funding is included in the baseline case.

Scenario-tested capital resilience

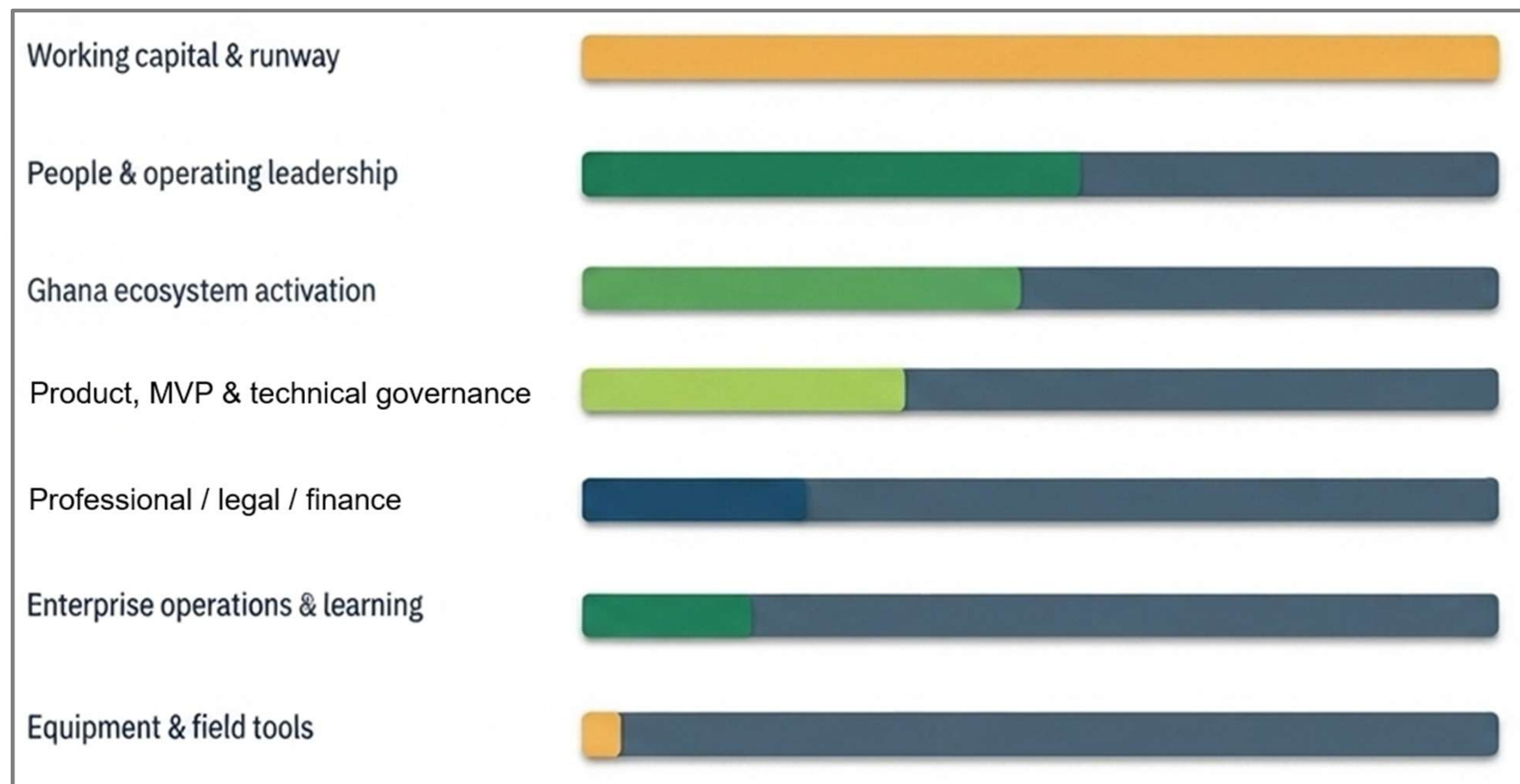
Scenarios vary cluster activation, transaction activity, completion performance and revenue timing.



Downside conditions delay operating break-even, but modeled liquidity remains positive across all three scenarios.

All scenarios assume \$1.0M Pre-Seed at launch and \$5.0M Institutional Seed after successful validation. No Series A funding is included.

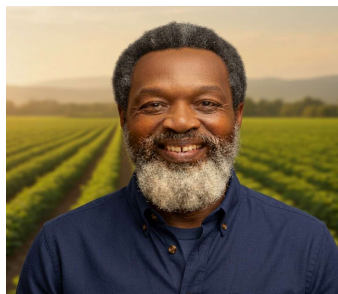
